PURPOSE

THE 5K EVENT IS INTENDED TO COMMEMORATE NATIONAL HISPANIC HERITAGE MONTH (SEPTEMBER 15TH – OCTOBER 15TH). THE MHA IS A NON-PROFIT ORGANIZATION THAT HAS BEEN PROMOTING THE HISPANIC CULTURE FOR 20 YEARS. IN ADDITION, WE AIM TO HELP HISPANICS INTEGRATE INTO MISSISSIPPI'S MAINSTREAM. PROCEEDS FROM THE RUN WILL BE USED TO FUND OUR THREE MAJOR PROGRAMS SUCH AS MHA PACO ROSALES SCHOLARSHIP, THE MHA READING PROGRAM AND MHA FOLKLORIC DANCE GROUP. NOT ONLY ARE THESE THE PROGRAMS ESSENTIAL IN CULTIVATING AND NURTURING OUR HISPANIC COMMUNITY, BUT A PERCENTAGE OF THE PROCEEDS WILL GO TOWARDS INFORMING ALL MISSISSIPPIANS ABOUT LATIN HISTORY AND TRADITIONS.

WAIVER BY REGISTERING FOR THE "RUN TO THE LATIN BEAT" 2017, I AM GIVING THE MS HISPANIC ASSOCIATION PERMISSION TO PUBLICIZE ANY EVENT PHOTOS CONTAINING MY IMAGE.

I (THE "PARTICIPANT") HEREBY ACKNOWLEDGE THAT HE/SHE HAS VOLUNTARILY AGREED TO PARTICIPATE IN THE "RUN TO THE LATIN BEAT" RACE. THE PARTICIPANT HEREBY FOREVER RELEASES, ACQUITS, DISCHARGES AND AGREES TO INDEMNIFY AND HOLD HARMLESS THE MISSISSIPPI HISPANIC ASSOCIATION, FLEET FEET, CITY OF RIDGELAND, MS TRACK CLUB AND ALL EVENT SPONSORS AND VOLUNTEERS, AS WELL AS ANY OFFICERS, DIRECTORS, AGENTS, EMPLOYEES, SUCCESSORS OR ASSIGNEES OF THE AFOREMENTIONED PARTIES, IN ADDITION TO ALL OTHER PERSONS WHO ARE EITHER DIRECTLY OR INDIRECTLY INVOLVED WITH THE RACE (COLLECTIVELY THE "RELEASED PARTIES"), FROM ANY AND ALL LIABILITIES, CLAIMS, DAMAGES AND DEMANDS AND ALL OTHER LIABILITIES OR WHATEVER KIND OF NATURE ARISING FROM OR RELATED TO THE RACE, INCLUDING BUT NOT LIMITED TO, ANY AND ALL LIABILITIES, CLAIMS DAMAGES AND DEMANDS ARISING FROM ANY PERSONAL INJURIES, LOSS OR DEATH OCCURRING AS A RESULT OF THE RACE. THE PARTICIPANT FURTHER AGREES THAT HE/SHE WILL NEVER INSTITUTE ANY ACTION OR SUIT, AT LAW, IN EQUITY OR OTHERWISE, AGAINST ANY OF THE RELEASED PARTIES, AND WILL NOT AID IN THE INSTITUTION OR PROSECUTION OF ANY SUCH ACTION OR SUIT AGAINST THE RELEASED PARTIES WHICH IN ANY WAY INVOLVES OR RELATES TO THE RACE. THE PARTICIPANT FURTHER STATES THAT HE/SHE IS IN PROPER MEDICAL CONDITION TO PARTICIPATE AND COMPLETE IN THE RACE AND IS NOT PARTICIPATING AGAINST DOCTOR'S ADVICE, NOR IS HE/SHE TAKING MEDICATIONS WHICH WOULD DETER HIS/HER HEALTH IN THE PARTICIPATION OF THE RACE. IF ANY ACT OF GOD FORCES THE CANCELLATION OF THE RACE, THE PARTICIPANT UNDERSTANDS THAT ENTRY FEES ARE NON-REFUNDABLE. THIS RELEASE SHALL BE BINDING UPON THE EXECUTORS, ADMINISTRATORS, PERSONAL REPRESENTATIVES, HEIRS, SUCCESSORS AND ASSIGNEES OF THE UNDERSIGNED.
